

REGULATIONS Individuals, Families and Groups

I hereby confirm with my signature that I have read and consent to the following "Sparti Platres Adventure Park regulations":

1. **Conditions of use:** Use of the facilities at "Sparti Platres Adventure Park" is at your own risk. As a participant you are responsible for any injuries or damages you may sustain during any activity. You are participating voluntarily. You are responsible for your safety.

2. Safety Information: Each participant must attend a safety briefing before using the facility and complete an instruction course under supervision of "Sparti" employees. Only the equipment provided by "Sparti" (after payment of the entrance fee and deposit of an ID) can be used. The equipment must be used in accordance with staff instructions and may not be given to or used by another person. Rental equipment must not leave "Sparti's" grounds and must be returned when the course has been completed. The maximum weight for participation is 110kg.

3. Equipment: When securing / transferring a carabiner onto the steel cable one of the carabiners must always be connected to the safety cable. In no case whatsoever should both carabiners be removed from safety cable at any stage of any course. The parent or legal guardian must always ensure that the child / children under their supervision follow correct safety procedures. Participants are required to wear appropriate clothing as well as sturdy, closed shoes. Only one person at a time may perform an exercise. A maximum of 2 people are allowed on the tree platforms. Only 1 person at a time may use the zip-line and only when no other person is in the arrival area. Deliberately placing heavy stress on the safety cables and zip-lines must be avoided for safety reasons.

4. Safety: You may not carry any objects (e.g. phones, cameras, keys, etc) which could fall and endanger other participants or persons. "Sparti" accepts no liability for lost items or for damage to any personal object or clothing. Long hair must be bound short and worn in an appropriate manner to prevent any possible contact with any cable and or equipment. Smoking is prohibited throughout the entire facility.

5. Liability: The instructions of the staff must be followed at all times. In case of violation or breach of such instructions, the person or persons concerned

may be asked to immediately leave "Sparti", and in such case there, will be no refund of the admission price. "Sparti" assumes no liability for accidents or damage caused by violation or breach of safety regulations as listed in writing and or as explained by any staff member.

6. Terms of Payment: "Sparti" reserves the right to close

the premises for safety reasons (including weather conditions, etc.) and if so, there will be no refund of the admission price. There will be no refund of the admission price for ending your visit to "Sparti" at your own request. Soiled or dirty clothing or body parts are a common potential risk when visiting a forest rope park and are therefore excluded from any damage claims.

7. Consent: The participants declare by their participation that they are not suffering from any physical / mental illness and that they are not under the influence of alcohol or drugs. Pregnant women are not allowed to use the equipment due to the health risk.

8. Minors: Children under 10 years of age must be accompa-nied by a parent or legal guardian (1 child per 1 adult, the parent or legal guardian shall be responsible for transferring the carabiner) Children under 15 years of age must be accom-panied by a parent or legal guardian (3 children / 1 adult). Juveniles (14 to 17 years of age) must show a signature consent of a parent or legal guardian. The signature of the parent or legal guardian confirms that they have read and taken due note of the park regulations and have informed the children / juveniles about the usage conditions. Parents and legal guardians are responsible for their children on "Sparti" grounds.

9. Photographs and Video Recordings: "Sparti" Reserves the right to photograph, film and make video and or Webcam recordings of the entire Forest Rope Park and participants using it for advertising and information purposes. If partici-pants do not agree with this policy they must explicitly inform "Sparti". With my signature I agree that my personal data can be used for advertising and marketing purposes of the Park unless I state otherwise.

10. Maximum stay: 3 hours (for every additional 30 minutes, €5 will be charged)

Waiver and release of Liability

This document releases "Eco Forest Rope Park Ltd" known as "Sparti Platres Adventure Park", together with its employees, hosts, organizers of events and activities ("Sparti") from all liability relating to injuries that may occur during any activity on the premises of the "Sparti Platres Adventure Park".

I understand and acknowledge the physical and mental rigors associated with the activities on the premises of the "Sparti" are inherently dangerous. I understand that such participation involves risks and dangers which might include, the potential for serious bodily injury, permanent disability, paralysis and loss of life or loss or damage to personal property. I hereby expressly and voluntarily assume all such risks and responsibility for any damages, liabilities losses or expenses which I might incur as a result of such participation.

By signing this document, I hereby release, waiver, and covenant not to sue, and further agree to indemnify, defend and hold harm-less "Eco Forest Rope Park Ltd" known as "Sparti Platres Adventure Park", together with its employees, hosts, organizers of events and activities, with respect to any liability, claim(s), demand(s), cause(s) of action, loss or expense of any kind of nature which may result from participation in any activity at the said park.
